Limited Warranty Subject to change without notice.

ECO Light LED Lighting Solutions is pleased to provide the following warranty for the periods shown below. This warranty covers ECO Light LED Modules when installed properly as a system.

ECO Light LED System Limited Warranty

ECO Light LED warrants each ECO Light LED Module to be free from defects in materials and workmanship, and to operate from the date of Purchase for the listed time periods and subject to the Terms and Conditions specified below.

If an ECO Light LED module fails to operate for the specified warranty period ECO Light LED will provide a free replacement component in accordance with the Terms and Conditions set forth below. **(labor not included).**

1. LED Module warranty period is valid for a mean operating temperature of 105°F at the specified tc point on the module. Exceeding the maximum recommended temperature at the tc point will void this warranty.

2. LED Module warranty period is valid only when proper power supply is used. Not using the recommended power supply voltage will void this warranty..

TERMS AND CONDITIONS

This warranty only applies when ECO Light LED Module is properly wired and installed; is operated using a suitable power supply within the electrical values recommended by ECO light LED; used in designed and approved locations for the application and in environmental conditions (temperature, humidity) within the normal specified operating range of the system. **This warranty does not apply to any abnormal use or use in violation of any applicable standard, code or instructions for use in installations.**

This warranty will not apply in the event of conditions demonstrating abnormal use or stress, including under/over voltage/current conditions, excessive switching cycles or operating hours or outside the following recommended operating conditions:

- Warranty Period is based on typical 8,760 hr./yr. Operation on a burning cycle of 24 hours daily
- Mean ambient operating temperature for LED Module: 80° F
- Operate at rated DC Voltage or DC Current

Replacement of ECO Light LED Module components with LED components of other manufacturers will void the entire warranty. Inappropriate use and selection of power supply will void the entire warranty.
